Executive Summary

MEYZEEK MIDDLE SCHOOL

Process of Developing the Comprehensive School Improvement Plan

Mission

Meyzeek's mission statement arose from the values and beliefs tacitly endorsed by Meyzeek's stakeholders. The transformation of that into words, "to provide a rigorous education in a developmentally-appropriate setting," came via the SBDM. The faculty and SBDM review the school's mission annually to ensure alignment and consensus among stakeholder groups.

Needs Assessment

Meyzeek's leadership team, which includes administrators, team leaders, and department chairs, conducted the initial needs assessment by reviewing disaggregated data. Departments met (thereby reaching all teachers) to mine for trends in their respective data.

Goals

Meyzeek's SBDM determined that the school's CSIP will include goals for each core discipline. The goals are based upon KCCT performance and the school's trajectory to reach 100% proficiency in all areas. Departments met and determined the strategies necessary for students to reach the goals.

Evaluation

A variety of assessments will benchmark progress, including the GPA, CCA, and PAS. The first two are evaluated each six weeks; the PAS has a fall, winter, and spring administration.

Stakeholders

Stakeholders included teachers, parents, and administrators. Their engagement occurred in SBDM meetings, department meetings, faculty meetings, team meetings, grade-level meetings, Gold Day professional development, and departmental professional development.
